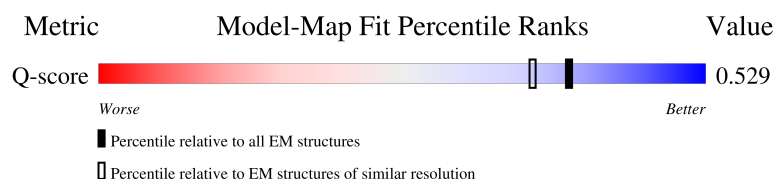
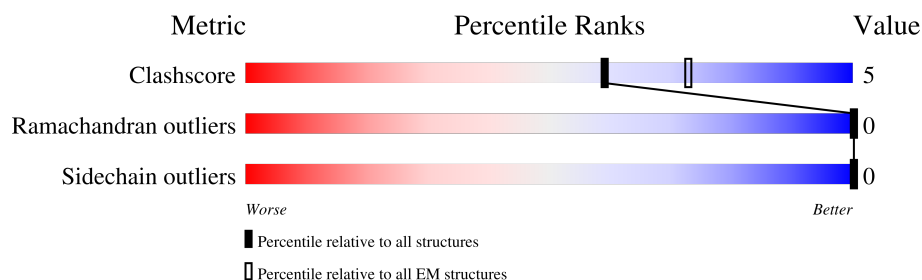

1 Overall quality at a glance

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

2 Entry composition

- The chemical structure of 6'OU (6'-O-uridine) is shown. It consists of a uracil base (a six-membered ring with two carbonyl groups and two NH groups) attached to a ribose sugar (a five-membered ring with hydroxyl groups at the 2' and 3' positions). The ribose sugar is linked to a phosphate group (a phosphorus atom bonded to four oxygen atoms, one of which is negatively charged). The phosphate group is further linked to a 6'-O-uridine moiety, which is a uracil base attached to a ribose sugar via its 6' oxygen atom. The structure is labeled with '6'OU' and '6'OH'.

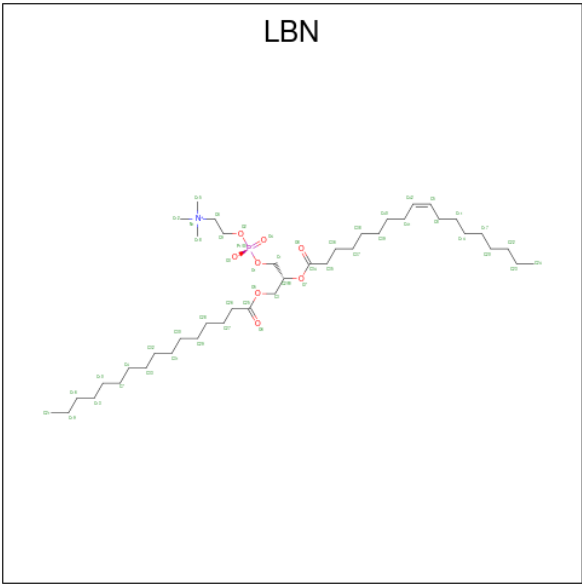

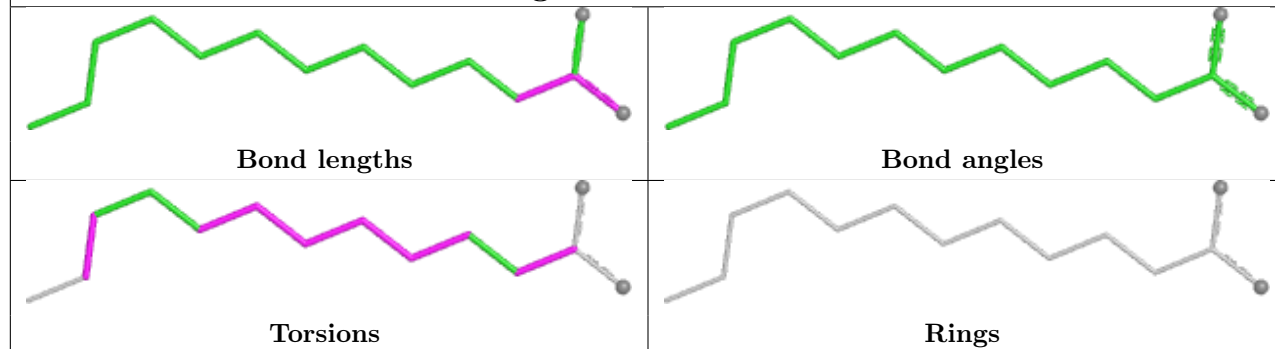
The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. If the average RMSD is greater than 60 degrees and the minimal RMSD between the ring in question and any Mogul-identified rings is also greater than 60 degrees, then that ring is considered an outlier. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

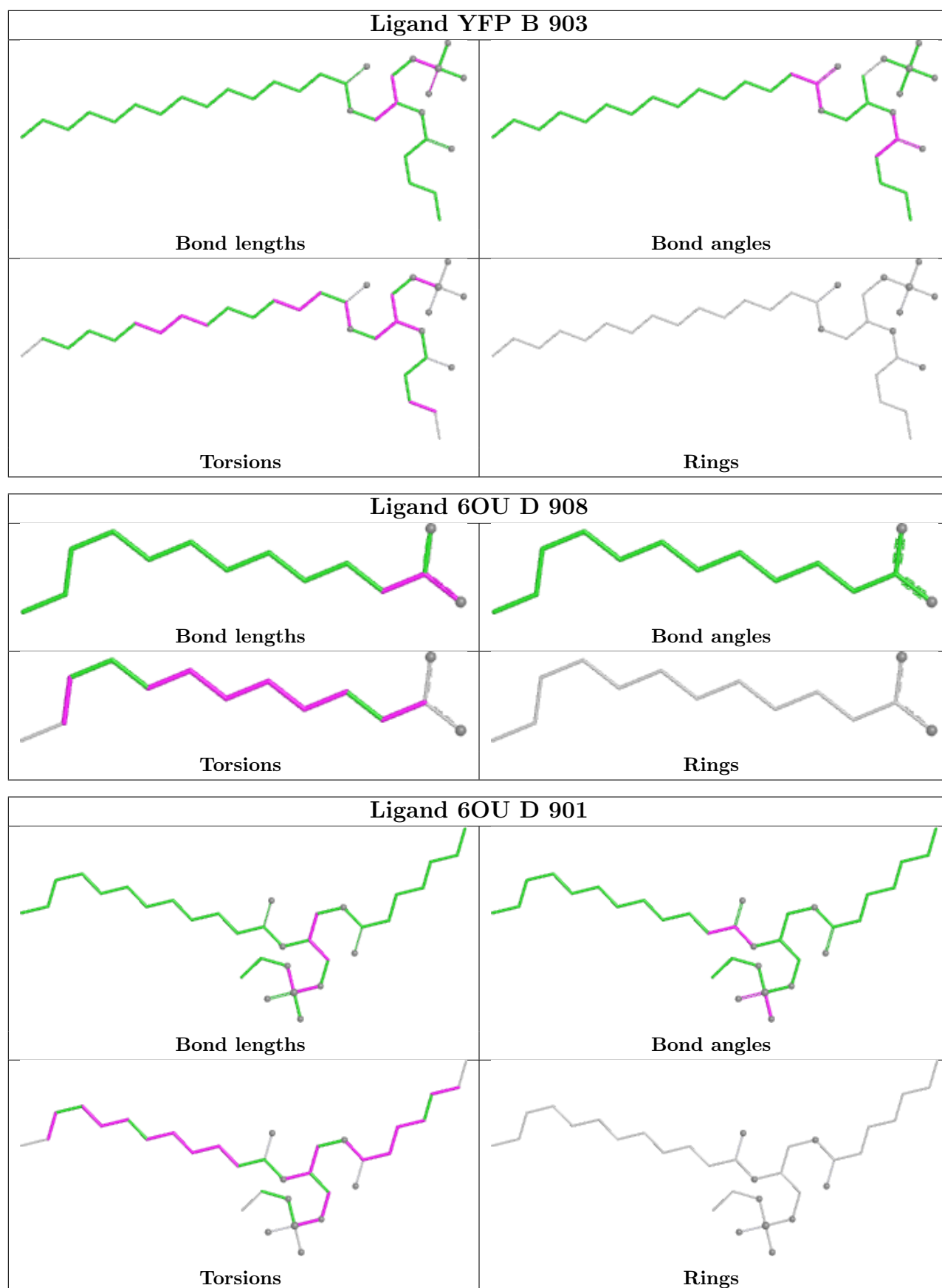


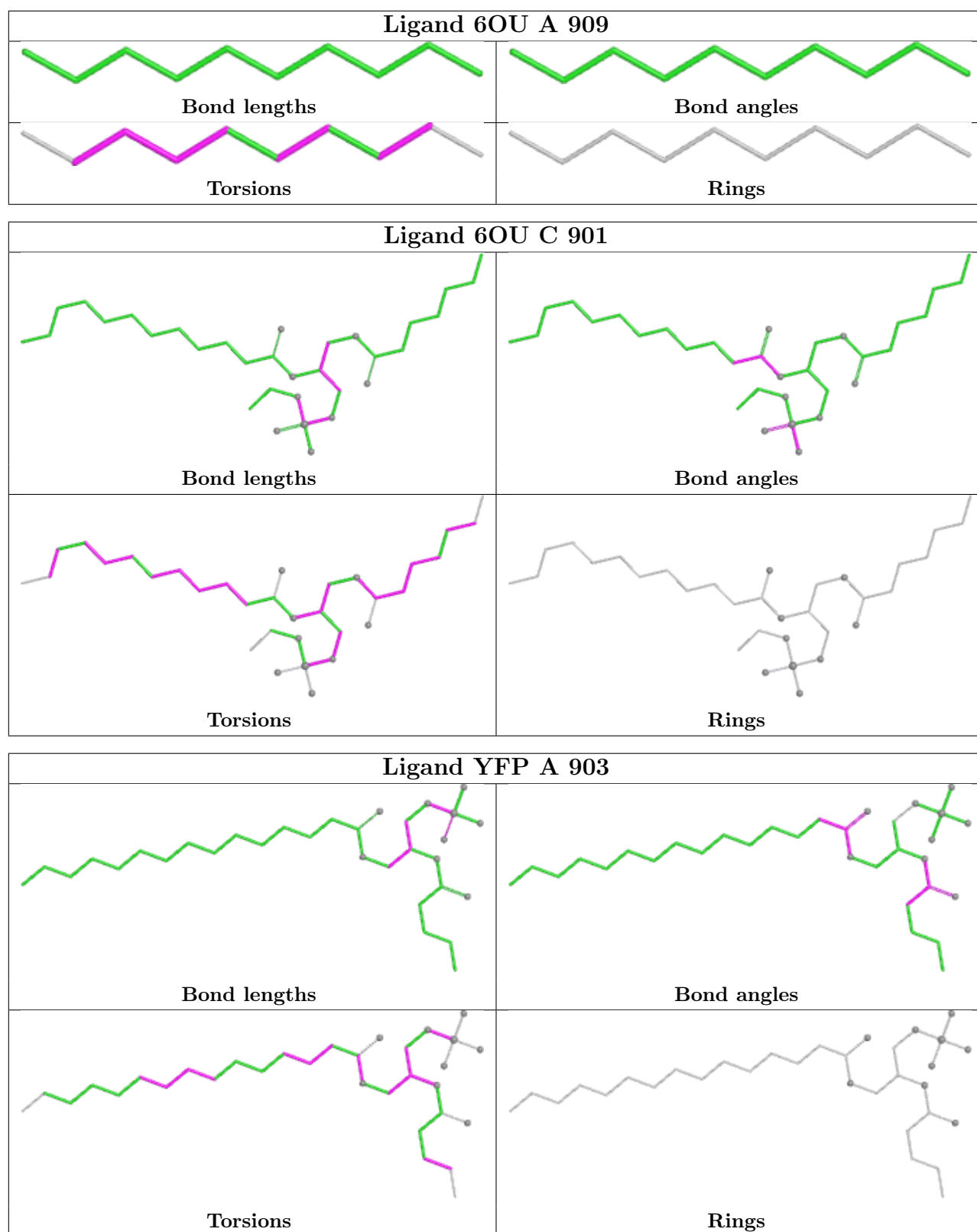

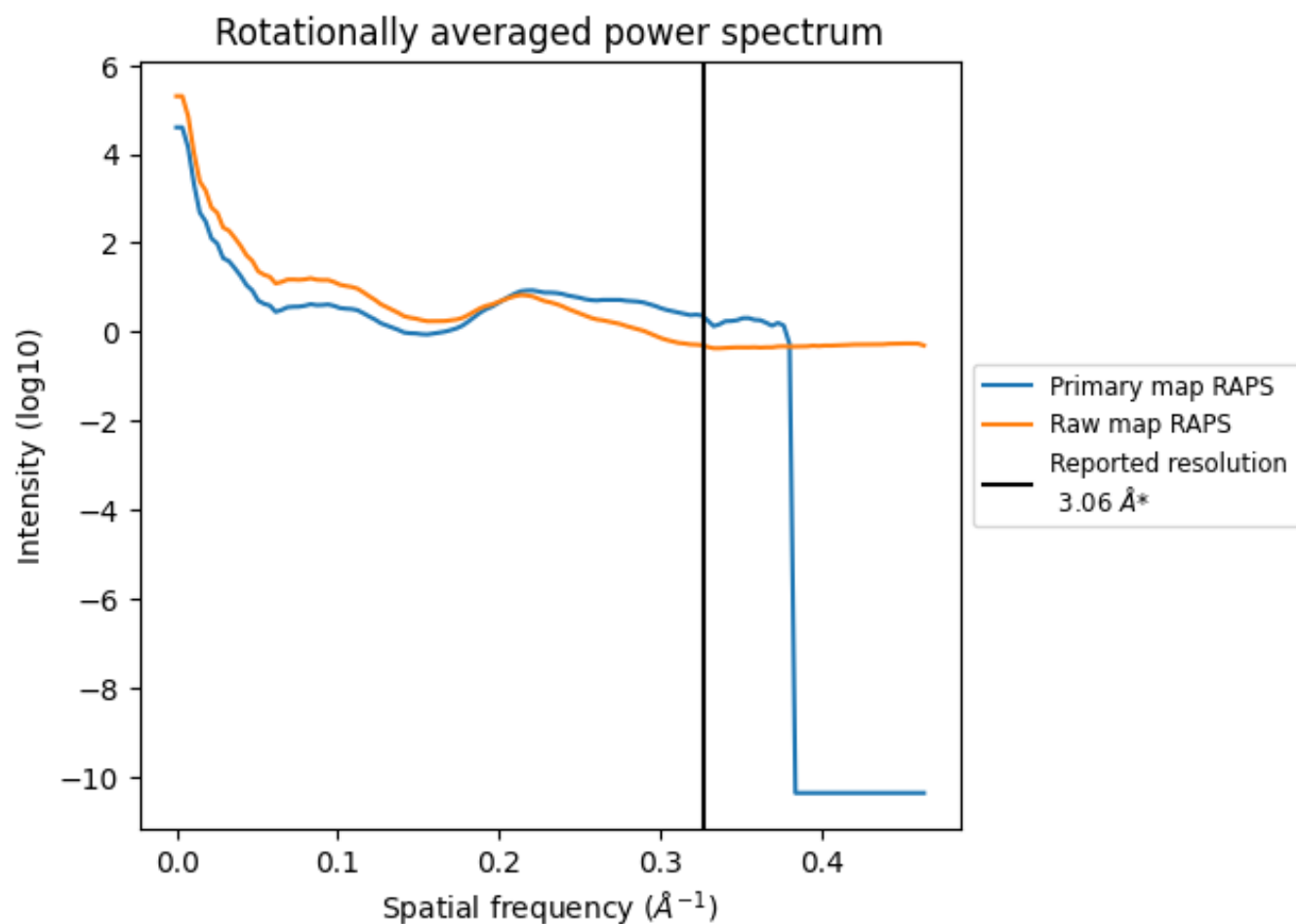

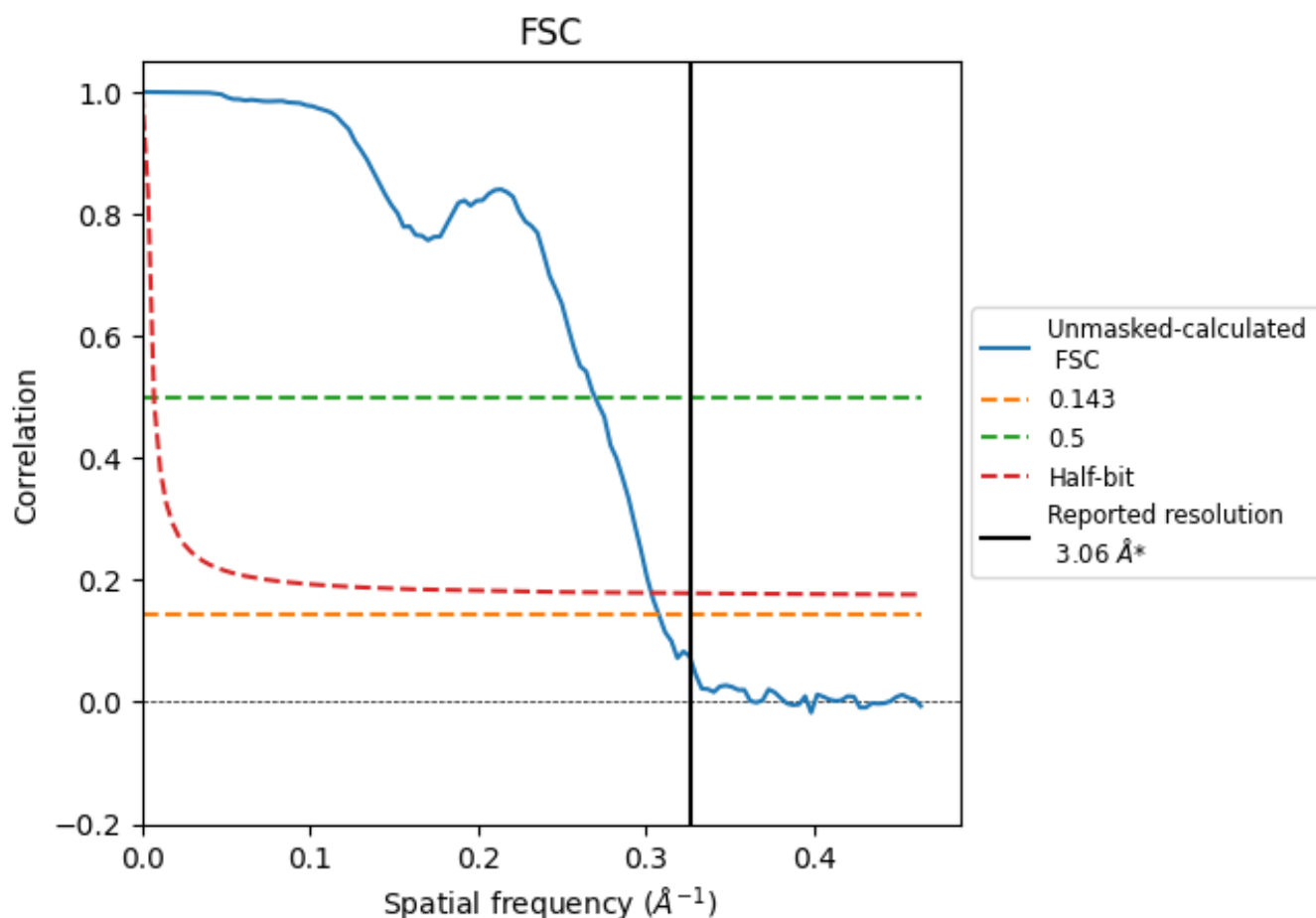

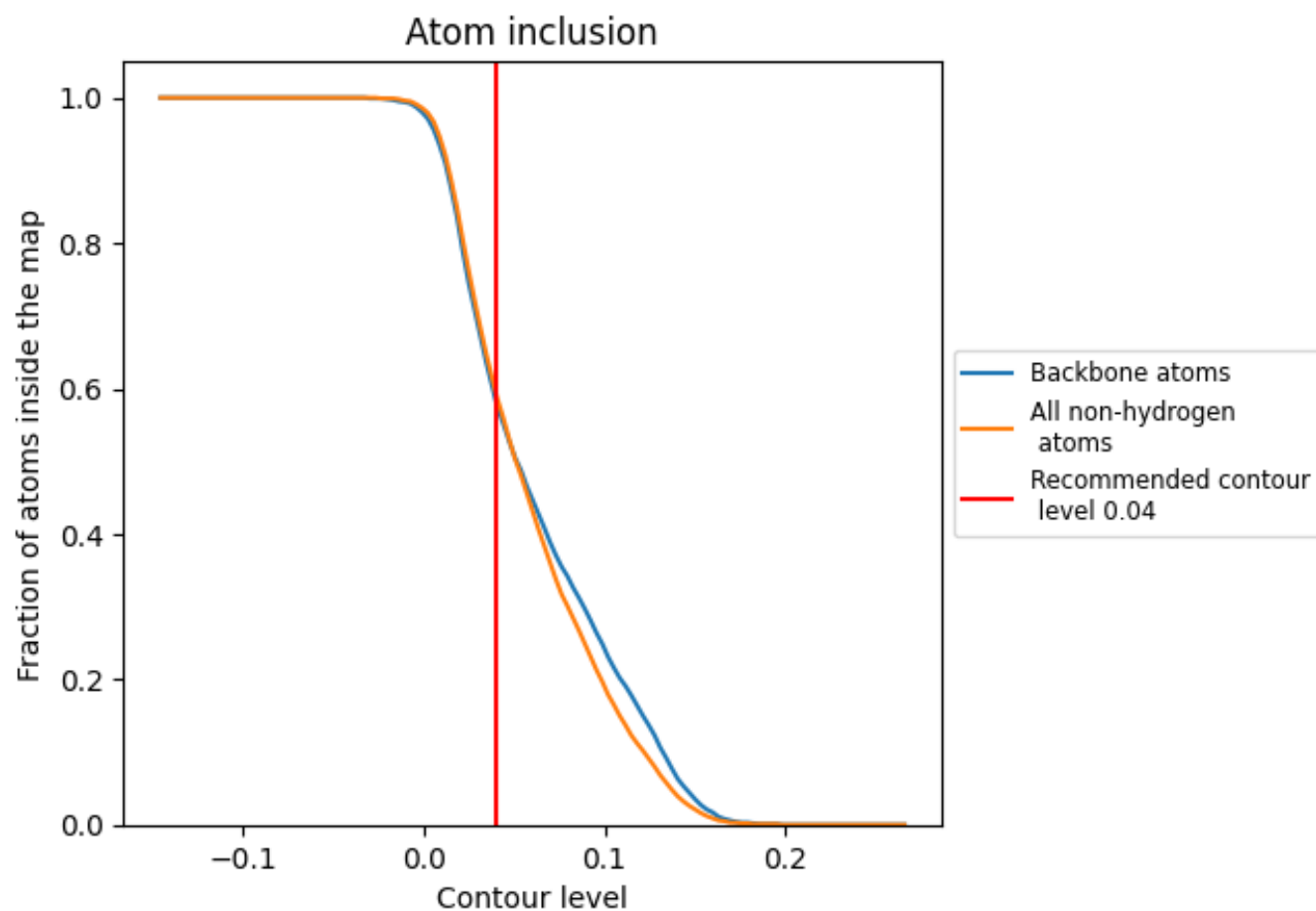
